**GENERAL INSTRUCTIONS FOR COMPLETING A
STALLION BREEDING REPORT**

1. Clearly print in dark colored ink or type all requested information. Delays in processing this report may result if information is omitted.
2. Use a separate form for each stallion for each calendar year.
3. A check, money order, Visa or MasterCard may be used for payment. When using a Visa or MasterCard, please complete the credit card information.
4. To aid you in filing this report, verify exposed mare's registered name and number by looking at the Certificate of Registration and properly record it on this form. You should also verify that the owner of the mare indicated on the Certificate of Registration is the person who contracted this breeding.
5. Handwritten signatures of the stallion owner or authorized agent and their entities and AQHA ID number are required for processing this report.
6. Retain a copy for your files and/or future use.
7. The owner or lessee of every stallion (both American Quarter Horse and Thoroughbred to which American Quarter Horse mares have been exposed) must make a written report showing the names and registration numbers of all mares exposed to said stallion since the previous November.
8. Thoroughbreds used for breeding American Quarter Horses must be listed with AQHA. To list a Thoroughbred with AQHA, we must receive a photocopy of the front and back of The Jockey Club certificate showing current ownership, four pictures of the horse (one of each side view, front and rear view) and a \$50 recording fee (\$85 for nonmembers). A Thoroughbred must be bred to a permanent registered American Quarter Horse for the offspring to be eligible for registration with AQHA. The offspring will be registered in the appendix registry.
9. An appendix registered horse must be bred to a permanent registered American Quarter Horse for the offspring to be eligible for registration with AQHA. The offspring will be registered in the appendix registry.
10. Mail the completed report to AQHA, P.O. Box 200, Amarillo, Texas 79168, postmarked by November 30 (June 30 below equator) to avoid paying a late filing fee.
11. If you have a current AQHA membership, the annual stallion breeding report filing fee is \$10 per stallion, plus \$3 for each mare reported. If you are a nonmember, you may purchase a membership at the time of this transaction to receive the benefit of discounted fees. Dues payments MAY BE deductible by members as ordinary and necessary business expenses; however, contributions or gifts to the American Quarter Horse Association are not deductible as charitable contributions for federal income tax purposes. However, donations to the American Quarter Horse Foundation ARE tax deductible to the extent allowed by law. If you do not wish to be an AQHA member, the Stallion Breeding Report filing fee is \$45 per stallion, plus \$6 for each mare.
12. An additional fee of \$10 per mare is required on stallion breeding reports received with postmarks after November 30 (June 30 south of equator) of the breeding year.
13. The report must include all breeding dates or dates of exposure.
 - a. Provide exact date(s) exposed – if more than one service is given mare, indicate the different dates.
 - b. If pasture exposed, provide date the mare was turned into the pasture and date she was taken out of pasture.
 - c. If bred using cooled and transported semen or frozen semen, check the appropriate box.
14. Include all mares owned and bred by the owner of the stallion, as well as mares owned by other parties.
15. You can file your report online at www.aqhamembers.com or the report should be made on a form provided free of charge by AQHA upon request, but is acceptable on any form so long as all necessary information is provided.
